

THURSDAYS IN OCTOBER 10 AM - 10 PM

- 1. One Diamond or Platinum Club Barona winner will be randomly drawn every 15 minutes from 10am to 10pm to select from five concealed prizes. If a Diamond player selects the lowest prize amount on his/her first turn, he/she will be given the option to select a different prize. Prize values range from \$500 to \$2,500:
 - a. \$2,500
 - b. \$1,500
 - c. \$1,000
 - d. \$750
 - e. \$500
- 2. Winners may choose to accept the prize paid in cash, free play, non-cashable promotional chips, or any combination thereof. Free play prizes will be loaded directly to winner's account and will be accessible for 365 days. Any cash or non-cashable promotional chip prizes must be claimed and collected within 30 days.
- 3. VIP players will be issued one entry per promotion day automatically by inserting their Diamond or Platinum card in any machine, or by opening a rating at any table game (including Chipless table games). Additional entries will be earned at a rate of one virtual entry per every 250 points earned on slots, keno, video poker, or table game from 12:15am to 10:00pm on each drawing day. Chipless table games do NOT accrue additional drawing entries.
- 4. It is the Club Barona member's responsibility to ensure that his/her card is properly inserted into the machine or given to a Table Games manager. Promotion eligibility is limited to one active Club Barona Card.
- 5. Players can win a maximum of one VIP Pick Your Prize prize per promotion day.
- 6. Winners are drawn at random. The drawing system will generate a list of eligible winners. An individual machine or table game win does not trigger a hot seat prize.
- 7. A Barona staff member will notify the Club Barona member playing at the randomly drawn machine or table that he/she may be a winner.
- 8. The potential winner must have a valid, unexpired, government-issued photo ID available immediately upon request that matches the name on the Club Barona Card. Those that do not match shall be disqualified. However,

if a known player has an expired ID, or does not have their ID with them, identity information on file will be acceptable to confirm a winner, which shall be verified in the CMS or Everi system using their Club Barona account.

A current Club Barona Card with imprinted photo will also be sufficient to confirm a winner. If that gaming position is vacant or occupied by a player other than the first name on the list, the Club Barona member whose name appears next on the list below the previous potential winner will be determined as the next potential winner. This process will continue until a winner is determined.

- 9. Should the drawing system malfunction, then manual procedures will be used.
- 10. Any applicable taxes, fees, and gratuities are the responsibility of the winner. Winner must verify 1099 or 1042-S information and complete a W-9 tax form as a condition of accepting any prize that brings the aggregate prize total to more than \$599 in a given year.
- 11. Barona Resort & Casino may request and/or require winners to complete and return a model release as a condition of accepting any prize package. By participating in this promotion, participants are giving consent for their image to be recorded for use in any and all media, whether now known or hereafter devised.
- 12. Barona staff, vendors, and entertainers, as well as players who are currently expelled from Barona Resort & Casino are not eligible to participate in casino promotions.
- 13. Barona Resort & Casino management reserves the right to modify or terminate this promotion at any time at their sole discretion with or without notice, subject to Gaming Commission approval. All rulings made by event management during the promotion are final; however, any patron who believes that he/she is entitled to payment for winnings from the promotion may file a complaint with Casino management within three (3) days of the play or operation at issue.
