

Barona Resorts & Casino - Banquets Department Tribal Member Terms and Conditions (GEC)

GENERAL INFORMATION – To help ensure a successful event, all details and arrangements must be completed at least 30 days (1-month) prior to the date of your function. Any Changes made within 14 days prior to the event, other than the number of people attending, will be accepted at the discretion of Barona Resort & Casino and may be subject to additional fees.

The client, guests or attendees may bring **No Food or Beverage on premise with the exception of Wedding or Birthday Cake**. **All other food and beverage must be supplied by Barona Resort & Casino.** Barona Resort & Casino prohibits the removal of food and beverage items from the premise by the client or any of the client's guests or attendees.

Client agrees to begin and end the event promptly at the scheduled time and agrees to have all guests and attendees and other persons associated with the event vacate the function area at the closing hour indicated.

Barona Resort & Casino will not assume any responsibility for the damage or loss of any merchandise or articles left on premise prior to, during or following your function.

All decorations must be approved by the Banquets Department and are subject to local fire code.

Appropriate labor fees will be charged in the event that more than standard cleanup is required at the conclusion of your function. This will include removal of excessive trash, confetti, cartons, etc., or the repair of damage to walls, flooring or fixtures.

Tribal Members may not book an event on behalf of a Non-Trial Member.

SECURITY –A Security guard is provided for any event serving alcoholic beverages. A fee of \$350 applies for a 4 hours period of bar service.

MENU SELECTION – Menus are to be selected and detailed at least 30 days (1-month) prior to the date of your event. Please note that minimums apply to some selections. Where applicable, the minimum number will be charged in the event of lesser attendees.

GUARANTEE – A final guaranteed attendance number must be received 72 hours (3 working days) in advance of your event. This number will be considered your minimum guarantee and will not be subject to reduction. Should a guaranteed number not be received, the expected number stated on your event order shall become your final guarantee. Barona Resort & Casino will set and prepare for 5% over the guaranteed number. Charges will be based on the guaranteed number or actual attendance whichever is greater.

SERVICE CHARGE, SURCHARGE & DISCOUNT – All food and beverage prices quoted will be subject to a 20% service charge. All special dietary requests are subject to a 15% additional charge per person. A 15% Tribal Discount applies to all Food & Non- Alcoholic Beverages.

DEPOSITS AND PAYMENTS – Deposit of \$250 will be required to confirm any event that requires catering of over 25 attendees. Final payment shall be due 48 hours prior to your event in the form of cash, check or credit card. We recommend all payments to be made three days prior to the event. If the payment is not made prior to the event, the Tribal Member will receive a bill within 30 days. Tribal Member may return the bill with a check or contact the Accounting Department at 619-328-3676 for credit card payments. Cash payments MUST be paid in person to our Banquets Management Team only. Please contact the Barona Government Building if you wish to pay through your per-cap.

CANCELLATION – Should cancellation occur, if notice is received 7 days in advance of the scheduled date, all deposits will be refunded. Cancellation less than 3 days in advance of the scheduled date shall cause forfeit of entire deposit.

IMPOSSIBILITY: Barona Resort & Casino may terminate this Agreement if performance is prevented, interfered with, or rendered more difficult due to utility shortages or restrictions, transportation or supply restrictions, Acts of God, labor disputes, government regulation, disaster, war, acts of terrorism, utility or any other cause beyond the parties' control. In addition, this Agreement may be terminated if a determination is made, in Barona Resort & Casino's sole discretion, that the event has the potential to negatively impact the health, safety or welfare of the staff and patrons of the Barona Resort & Casino.
