



Thursdays in December 10am–10pm

1. Barona's VIP Holiday Hoopla takes place from 10am – 10pm on promotion days.
2. Diamond and Platinum Club Barona members earn one automatic virtual entry upon inserting their card into any slot, keno, or video poker machine, or having a rating opened at any table game. Additional entries will be earned at a rate of one virtual entry per every 250 points earned from 12:15am to 10pm on each promotion day.
3. It is the Club Barona member's responsibility to ensure that his/her Club Barona Card is properly inserted into the machine or given to a Table Games Manager. Promotion eligibility is limited to one active Club Barona Card; any additional active cards do not increase the odds of being drawn.
4. Every 15 minutes, one (1) VIP player will be drawn to participate in Barona's VIP Holiday Hoopla Pick a Gift game.
5. Hot seat winners will select a gift box with a prize value concealed with values of \$500, \$1,000, and \$2,000. (Note: Diamond members who select the \$500 value first will have one opportunity to select another gift.)
6. Hot seat winners will have the choice to accept their prize in cash, free play, and/or non-cashable promotional chips.
7. The hot seat system will generate a list of eligible VIP winners. An individual machine or table game win does not trigger a Barona VIP Holiday Hoopla prize.
8. The list of winners generated by the hot seat system will be used to determine winners. The name appearing at the top of the list will be the first potential Barona VIP Holiday Hoopla winner.
9. A Barona staff member will notify the Club Barona member playing at the randomly drawn machine or table that he/she may be a winner.
10. The potential winner must have a valid, unexpired, government-issued photo ID available immediately upon request that matches the name on the Club Barona Card. Those that do not match shall be disqualified. However, if a known player has an expired ID, or does not have their ID with them, identity information on file will be acceptable to confirm a winner, which shall be verified in the CMS or Everi system using their Club Barona account. A current Club Barona Card with imprinted photo will also be sufficient to confirm a winner.
11. If that gaming position is vacant or occupied by a player other than the first name on the list, the Club Barona member whose name appears next on the list below the previous potential winner will be determined as the next potential winner. This process will continue until a winner is determined.
12. Once the Barona VIP Holiday Hoopla winner has been verified, the winner will play the Pick a Gift game.
13. Diamond and Platinum players actively playing at the time the Hot Seat winner is confirmed, and at the same bank or table as that Hot Seat winner, will win the Holiday Bonus: \$100 for Diamond, \$50 for Platinum.
14. Hot Seat Winners that choose to have their prize paid in cash and/or non-cashable promotional chips will be paid out at the Main Cash Services. Winners that choose free play will have their prize uploaded to their Club Barona account. Winners will have 30 days after the promotion's end date to change the method of prize payment.
15. Players may be drawn to play Pick a Gift during VIP Holiday Hoopla once per promotion day, but can win Holiday Bonus prizes multiple times, so long as they are at the same bank or table as the confirmed Hot Seat winner (see rule #13).
16. Should the hot seat system malfunction, manual procedures will be used.
17. Any applicable taxes, fees, and gratuities are the responsibility of the winner. The winner must verify 1099 or 1042-S information and complete a W-9 tax form as a condition of accepting any prize that brings the aggregate prize total to more than \$599 in a given year.
18. Barona Resort & Casino may require winners to complete and return a publicity release as a condition of accepting any prize payout. Winners are giving their consent to be recorded for use in any and all media, whether now known or hereafter devised.
19. Barona staff, vendors, and entertainers, as well as players who are currently expelled from Barona Resort & Casino are not eligible to participate in casino promotions.
20. Barona Resort & Casino management reserves the right to modify or terminate this promotion at any time at their sole discretion with or without notice, subject to Gaming Commission approval. All rulings made by event management during the promotion are final; however, any patron who believes that he/she is entitled to payment for winnings from the promotion may file a complaint with Casino management within three (3) days of the play or operation at issue. The patron shall be notified that he/she may submit a written complaint to the Barona Gaming Commission within fifteen (15) days of receipt of the notification.
21. Any participant found to be abusing the promotion rules or tampering with the promotion in any way may be disqualified and declared ineligible for any prize.
22. Offer is subject to all Federal and Tribal laws and regulations.
